BOXER RESCUE—SHERRY JOHNSON PRESENTED A CHECK FOR \$500.00 TO REPRESENTATIVES OF ATLANTA BOXER RESCUE.

THE REPRESENTATIVES OF ATLANTA BOXER RESCUE GAVE THE FOLLOWING REPORT:

DOGS RESCUED TO DATE—125.

DOGS ADOPTED TO DATE—112.

THE RANGE OF DOGS IN FOSTER HOMES IS FROM 10-30 DAYS. CURRENTLY THERE ARE 25 IN FOSTER CARE WITH A STANDING COMMITMENT FOR 2 OF THEM.

SIXTY-FIVE DOGS HAVE TESTED POSITIVE FOR HEARTWORM IN THE PAST 24 MONTHS WHICH IS AN INCREASE OVER THE PRIOR REPORTING PERIOD. THIS MEANS MORE EXPENSE IS INVOLVED WITH THE TREATMENT AND ALSO A LONGER STAY IN FOSTER CARE.

THE RESCUE ORGANIZATION REPORTS A SUCCESSFUL FUND RAISER WITH BOXERSTOCK THIS YEAR AT JIM MILLER PARK ; AND, WERE VERY EXCITED TO SEE REPRESENTATIVES OF THE GEORGIA BOXER CLUB, SUSAN LICHTENBERGER AND SHERRY JOHNSON IN ATTENDANCE.
