

Georgia Boxer Club General Meeting

Sherry called the meeting to order and thanked Andrea for hosting the meeting and welcoming us into her home.

Voted and passed by 5 to 2. Debbie advised that would allow us to have made a small profit.

Discussion ensued with regard to fund raisers. It was decided to charge \$5 per person for dinner in April at our annual awards banquet. Motion made by Nancy Reidy and seconded by Sherry Johnson. Vote was unanimous and passed. Decision to have the silent auction at the Fall 2015 show and some type of raffle at the Spring 2015 show.

Veteran Dog trophy is currently still unpledged for the Fall 2015 show.

Lisa Crowder Spring 2015 show chairperson advised that the show is on track. Darryl Vice is our judge and a reminder that this Perry show will be 5 days beginning on Wednesday.

Debbie McAlpine Fall 2015 show chairperson advised that our judge is Carmen Battaglia. All is on track.

Bridget Brown Spring 2016 show chairperson will be sending out judge nominations soon.

A motion was made by Bridget Brown and seconded by Debbie McAlpine to accept ABC's electronic mailings rather than pay an annual fee for paper mailings. All in attendance agreed.

Debbie McAlpine advised that she had only received 1 champion certificate for 2014 and if you finished a champion in 2014 – please get her a copy of the certificate so she can recognize you and your dog at the Perry awards banquet.

Debbie advised that several members had still not paid their 2015 dues and to pay your dues now to continue your membership.
